Capital Access Financial Systems (CAFS) Partner Instructions <u>Setting up roles</u>

CAFS is accessed via the production URL at https://caweb.sba.gov. If you have questions, contact CLS@SBA.gov. The instructions below explain how to add roles to your CLS user id.

Prerequisite(s): CLS Account.

- 1. Go to the production or test URL.
- 2. Log into the system.
- 3. At the top right, select the person icon (see below).



- 4. Select "Request Access to CAFS Systems".
- 5. Click on the folder, select the box, and enter the location id for each required access level. (NOTE: LSPs should enter lender location ids).
- 6. You will receive an email that the account has been updated. THIS IS NOT AN APPROVAL FOR ACCESS.
- After the access is approved by the AO (they will have 48 hours from your request), Program Office and the CLS security team, you will receive an email from <u>cls@sba.gov</u>.
